

## Terminate/Reinstate Subscriber

Quick Reference Guide (QRG)

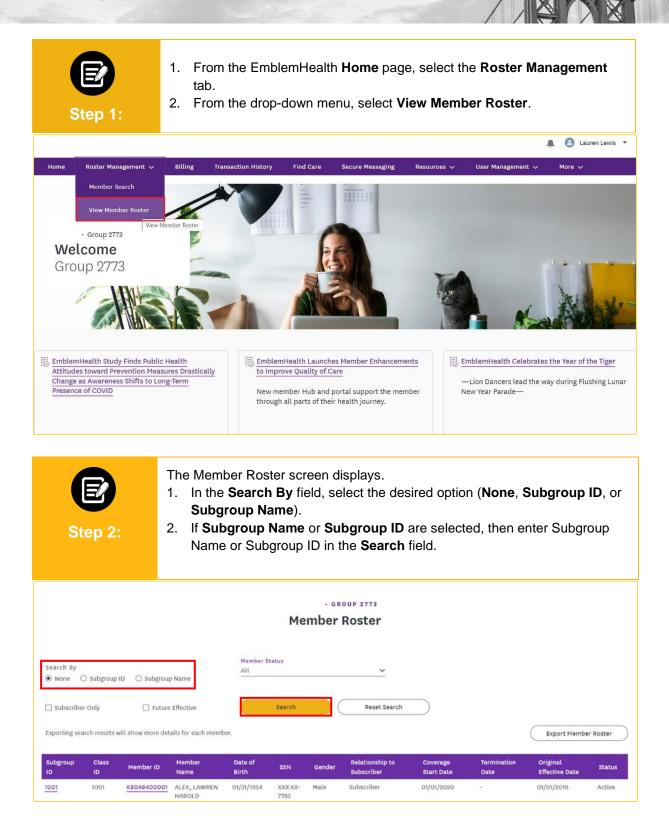
This Quick Reference Guide (QRG) will provide an overview of the process for reinstating and terminating subscriber.



Let's look at the steps in detail to Terminate Subscriber.

Purpose: To Reinstate and terminate Subscriber.









#### 1. Click Search.

Note: Check the Subscriber Only checkbox to search for Subscribers only (thereby excluding Dependents). Check the Future Effective checkbox to search only for members whose coverage is Future Effective. The Member Status drop-down menu defaults to All. You can select Active or Inactive.




